

## Additional Shipping Line Australia / NZ Trade lane notifications of note:

Mainfreight Transport has advised that due to fuel price fluctuations, the Fuel Adjustment Factor has decreased by 0.80% from Monday the 7<sup>th</sup> of September. For the majority of their customers, the new Fuel Adjustment Factor will be 0.00%.

Hapag Lloyd has advised that with effect from the 7<sup>th</sup> of October, they will revise the Booking Cancellation Fee (BCF) for cancellations to NZ\$100 per booking (subject to GST), and for Transfers and Reductions to NZ\$100 per booking (GST not applicable). This fee applies to all bookings that are cancelled, transferred to another vessel or reduced within one working day from the vessel's cargo cut-off. Please note that relevant terminal roll-over fees may also apply.
