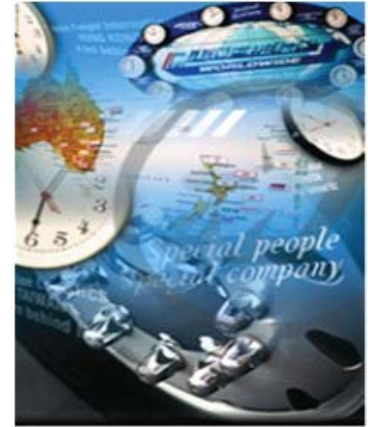

Additional Shipping Line South East Asia / NZ Trade lane notifications of note:

MOL has announced the restructuring of its South East Asia and NZ service into three loops. Their existing NZX service will be enhanced by space on the NZ1, NZ2 and NZ3 services with effect from November 2015. These services are operated by Maersk, and will allow MOL to offer services to and from Tanjung Pelepas, Singapore, Auckland, Tauranga, Napier & Lyttelton.

Mainfreight Transport has advised that due to fuel price fluctuations, the **Fuel Adjustment Factor** has **decreased by 0.80%** from Monday the 7th of September. For the majority of their customers, the new Fuel Adjustment Factor will be 0.00%.

MSC has advised that due to the current port congestion in Shuwaikh, they have implemented a **Port Congestion Surcharge (PCS)** for shipments ex Australia and NZ. Effective from the sailing date of 14th September, the PCS will be **US\$100 per TEU**, and this amount will be charged on a collect basis.

Hapag Lloyd has announced that the **Congestion Surcharge Destination (CGD)** has been revised for all imports to Shuwaikh. The new cost will be **US\$200 per TEU** effective from the 7th of September.

OOCL has also advised that berthing delays and congestion are continuing in Shuwaikh, resulting in additional operational costs. In view of this, OOCL wishes to advise that the **Port Congestion Surcharge (PCS)** has been increased from US\$100 per TEU to **US\$200 per TEU**, effective from the 1st of September. This Congestion Surcharge will be collected at destination.

Hapag Lloyd has advised that with effect from the 7th of October, they will revise the **Booking Cancellation Fee (BCF)** for cancellations to **NZ\$100 per booking** (subject to GST), and for Transfers and Reductions to **NZ\$100 per booking** (GST not applicable). This fee applies to all bookings that are cancelled, transferred to another vessel or reduced within one working day from the vessel's cargo cut-off. Please note that relevant terminal roll-over fees may also apply.
