Additional Shipping Line Europe / NZ Trade lane notifications of note:

MOL has advised they will be implementing a **Russia Winter Surcharge** for all shipments to and from **St Petersburg** and **Ust Luga**. This surcharge will be effective from the **1st of December**, and will be **US\$100 per TEU**.

Shipping Line Surcharges & Fees

Mainfreight Transport have advised that as of **Monday the 6th of November**, the **Fuel Adjustment Factor** will increase by 0.80 percentage points. This increase takes the price into the 125 – 130 cents per litre category. For the majority of their customers, the new Fuel Adjustment Factor will be **0.80%**.

MSC have advised that the congestion situation in **Shuwaikh, Kuwait** has subsided, and the **Congestion Surcharge** is no longer applicable. However, congestion at **Shuaiba, Kuwait** has intensified during recent weeks, and as a result a **Congestion Surcharge** of **US\$200 per TEU** has been applied effective from the **25th of October**.
