**USA Port Strikes**

**Los Angeles and Long Beach ports** were affected by an Office Clerical Union (OCU) contract dispute from November 27, which caused 10 out of 14 terminals to close for a period of 8 days as International Longshoremen and Warehouse Union (ILWU) members refused to cross the picket line to work. The terminals were reopened on December 5, and the ports, trucking companies and cargo handling facilities are now working with the impacted vessels and shipments for both imports and exports.
